FORMER R+C MANAGING PARTNER REFLECTS ON HIS CAREER IN *BUSINESS LAW TODAY*

The Honorable Alvin W. Thompson, former managing partner of Robinson+Cole, was interviewed for the Member Spotlight column in the January 2014 issue of *Business Law Today*, a publication of the American Bar Association (ABA). Now a judge for the U.S. District Court, District of Connecticut, Judge Thompson has devoted much of his life to public service, serving on boards of numerous organizations, both civic and charitable. Of note, his longest involvement has been as a member of the local Advisory Board of the Salvation Army. In 2008, he received the Edwin Archer Randolph Diversity Award from the Lawyers Collaborative for Diversity, a nonprofit that works to advance the professional status of attorneys of color and women in law firms throughout Connecticut. In addition, he has served in various leadership roles in the ABA. In the article, Judge Thompson reflects on his career path in the legal field, in particular

what inspired him, how he dealt with being a minority, and why he focused on banking and finance as a practicing lawyer. During his tenure at Robinson+Cole, he served as managing partner for three years, the first African-American to lead a large Connecticut law firm. HARTFORD LAWYERS COACH STUDENTS TO PRESENT SIMULATED TRIAL

Insurance litigation lawyers J. Tyler Butts and Dominic Spinelli helped ninth and tenth grade students from Hartford Public High School's Law and Government Academy prepare for and present a simulated trial. The program, held on May 1, 2014, was part of the federal judiciary's celebration of Law Day. Mr. Butts and Mr. Spinelli coached the students on the key elements of trial, including opening and closing statements and the questioning of witnesses. The trial was presided over by Senior District Court Judge Dominic J. Squatrito and featured closing remarks from professor Richard Wilson from the University of Connecticut School of Law. Law Day was first celebrated in 1958 to provide an opportunity to reflect on the role of law in the foundation of the country and to recognize its importance for society.
