MEGAN NAUGHTON JOINS CONNECTICUT'S STATEWIDE LEGAL SERVICES BOARD OF DIRECTORS

Megan R. Naughton, co-chair of Robinson+Cole's Immigration Group, has joined the Board of Directors of Connecticut's Statewide Legal Services (SLS). SLS, part of the Connecticut Network for Legal Aid, consists of several nonprofit legal services organizations whose shared mission is to improve the lives of Connecticut's poorest citizens by providing free legal services to low-income individuals. SLS empowers low-income people in Connecticut to obtain justice by providing tools and information to address their civil legal needs. The organization believes that everyone should have access to justice and provides advice over the phone, mails information, or refers clients to a legal services office or private lawyer at no cost to the client.

ROBINSON+COLE NEGOTIATES FAVORABLE SETTLEMENT FOR ECHO

Land use lawyers Brian R. Smith and Evan J. Seeman negotiated a favorable settlement on behalf of Eastern Connecticut Housing Opportunities, Inc. (ECHO) that will save ECHO more than \$35,000 in real property tax payments. Mr. Smith and Mr. Seeman first challenged the City of Norwich's assessments of three ECHO properties at the local level, before the City of Norwich Board of Assessment Appeals, and then commenced suit in the Superior Court. ECHO can use the savings to further its goal to provide affordable housing to low-income families in southeastern Connecticut.

PETER KNIGHT AND PRIYA MORGANSTERN SPEAK TO QU STUDENTS

Peter Knight, pro bono partner, and Priya Morganstern, director of the Pro Bono Partnership's Hartford

program, traveled to Hamden on April 7, 2015, to meet with students at the Quinnipiac University School of Law to discuss pro bono opportunities for young lawyers. Mr. Knight and Ms. Morganstern gave complementary presentations from their perspectives as a lawyer in private practice and a pro bono services provider. Whether headed for private practice, in-house counsel, or the public sector, the law students were keenly interested in incorporating pro bono work in their practices.

JIM NAULT REPRESENTS ROBINSON+COLE AT INTERVAL HOUSE RECEPTION

Business litigation lawyer James R. Nault represented the firm at a National Association of Women Lawyers (NAWL) event, the "Night of Giving Reception," held in the Hartford office of Jackson Lewis P.C. on May 5, 2015. In lieu of a registration fee, attendees at the reception, which benefited Interval House Connecticut, were asked to bring gift cards for area grocery stores, drug stores, and department stores; sheets, blankets, and comforters; and pajamas for women and children.

At the reception, which Robinson+Cole co-sponsored, Cecile Enrico, the executive director of Interval House, and Karen Jarmoc, the chief executive officer of the Connecticut Coalition Against Domestic Violence (CCADV), both spoke about the work their organizations do to combat domestic violence and expressed appreciation for support from the firm and other contributors.

NAWL promotes the interests and progress of women lawyers and women's legal rights. Interval House works to prevent and break the cycle of family and intimate partner abuse by providing a 24-hour hotline, crisis counseling, emergency shelter, support groups, criminal and civil court advocacy, information and referrals, community education, and a program for the children of clients.

BRIAN MORAN RECEIVES COMMUNITY IMPACT AWARD FOR *THE JUSTICE IMPERATIVE*



Robinson+Cole partner Brian E. Moran received the Bridgeport Reentry Collaborative's Urdang-Torres Community Impact Award on March 27, 2015, at Housatonic Community College in Bridgeport, Connecticut, for his book *The Justice Imperative: How Hyper-Incarceration Has Hijacked the American Dream*. This award honors a person, agency, or advocate who has worked tirelessly to promote the betterment of those reentering society from incarceration.

In *The Justice Imperative*, Mr. Moran and the Malta Justice Initiative tackle the problem of the rapidly growing prison population in the United States. The book outlines 30 specific reforms for Connecticut's legislative and executive branches to consider that look to less costly, more effective, and more humane alternatives.
